Nielsen, whereby the shareholders of DanDrit A/S agreed to exchange their shares for shares of the Issuer. As a result of the Share Exchange, the Issuer changed its name DanDrit Biotech USA, Inc. and Dr. Rosenberg a director of the Issuer.
